4. **Application No. UP-1070-26, Stanley Park Auto and Mike's Towing LLC:** Consider adoption of proposed Resolution R26-112 to authorize a Special Use Permit, pursuant to Section 24.1-306 [Category 12, No. 18] of the York County Zoning Ordinance, to establish a towing service/auto storage and impound yard on an 11-acre parcel located at 1570 Penniman Road (Route 641).
